You are invited to join in the competition for the 2015 writing award, recognizing an essay on any area of **municipal securities regulation.** 

The essay will be part of The Municipal Securities Rulemaking Board Gallery on Municipal Securities Regulation, opening December 1, 2015 in the virtual museum and archive of the history of financial regulation at <a href="https://www.sechistorical.org">www.sechistorical.org</a>.

### **Eligibility**

The competition is open to all visitors to the virtual museum and archive at www.sechistorical.org.

#### Submission

- All applicants must complete and sign the writing award release. No submission will be considered without a completed and signed release. In the release, the applicant will:
  - Attest that the essay is his/her own work, and is single-authored.
  - Confirm that the essay has never been published in any print or electronic format.
- The essay must be in English, and must be a maximum of 3,000 words, inclusive of optional footnotes, bibliography or tables.
- The essay must be submitted in Times New Roman 12-point type with 1-inch margins.
- The essay and release must be submitted in hard copy by postal mail to:

- All submissions must be received by December 31, 2014.
- Submissions will not be acknowledged or returned.

## Review

The curator of The Municipal Securities Rulemaking Board Gallery on Municipal Securities Regulation will chair a review jury of practitioners and professors of accounting and auditing, economics and law. The jury, in its discretion, will make its recommendation of the award recipient to the Executive Director, SEC Historical Society for final selection.

#### Accession

The essay selected will be permanently added to Papers in the virtual museum and archive at <a href="www.sechistorical.org">www.sechistorical.org</a>, and linked within The Municipal Securities Rulemaking Board Gallery on Municipal Securities Regulation.

#### Award

The award recipient will receive a \$5,000 prize at the Society's June 2015 Annual Meeting program in Washington, D.C.
