1967 The transition from Judge Oren Allred to Gerald Boltz as Regional Administrator took place. Linda Cox Pitt, Wilma S. Fonville, and Thomas W. McIlheran join the SEC. Fort Worth Regional Office is located in the Federal Courthouse. President Johnson was in office and the first successful human heart transplant took place.

1968 Civil rights leader Martin Luther King was assassinated and students protested the Vietnam War.

1969 President Richard M. Nixon took office and Armstrong & Aldrin became the first men on the moon. Woodstock.

1970 Apollo 13 crisis in space.

1996 Kathleen Stewart retires from the SEC. Harold F. Degenhardt joins the SEC as District Administrator.

1997 Bill Clinton begins second term. Cloning of animals. Oklahoma Bombing.
