DEAR MR PRESIDENT:

I SHALL BE IN WASHINGTON, D.C. FROM THE 30TH OF MARCH UNTIL THE 6TH OF APRIL AND WOULD LIKE TO PAY YOU MY RESPECTS.

WHEN YOU WERE GOVERNOR IN 1973 YOU WROTE ME SOME ADVICE WHICH HAS BORNE GOOD FRUIT AND I WOULD LIKE TO PERSONALLY – AND IN PERSON – THANK YOU FOR SUSTAINING ME THROUGH SOME VERY HARD TIMES WHEREIN I WAS IN MORTAL COMBAT WITH A VERY HARD TO SEE ENEMY...THE SECURITIES EXCHANGE COMMISSION.

THEN ON MARCH 6TH 1981 THE NEW YORK STOCK EXCHANGE BROKE AN IMPASSE BY MAILING US A LETTER WHICH REDEEMED OUR POSITION BY POSITIVE CONFIRMATION, AND BROKE A DEADLOCK BETWEEN THE SECURITIES EXCHANGE COMMISSION POSITION AND THAT OF THE FEDERAL RESERVE BOARD OVER THE VAST DISTINCTION THAT EXISTS BETWEEN A FEDERAL RESERVE BOARD 50 PERCENT MINIMUM MARGIN DAY ORDER AND A NEW YORK STOCK EXCHANGE 25 PERCENT MINIMUM ORDER DAY TRADE (WHICH TERMS THE SECURITIES EXCHANGE COMMISSION HAD SUBORNED TO THE CALIFORNIA COURTS TO BE SYNONYMOUS).

MAY I HAVE THE HONOR OF PRESENTING YOU PERSONALLY WITH THESE INCOMPATIBLE POSITIONS TAKEN BY THE SECURITIES EXCHANGE COMMISSION, ETC. SO THAT YOU MAY JUDGE FOR YOURSELF AS TO THE COMMISSION'S COMPETENCY TO CARRY OUT ITS MANDATE TO "PROTECT THE PEOPLE'S INTEREST"??? -- AND SO THAT YOU MAY PERSONALLY HAVE THE SEC TAKE

JUDICIAL NOTICE OF INCONTROVERSIAL FACTS???(SINCE WE HAVE BEEN SO FAR TO DATE UNABLE TO OURSELVES GET THE SECURITIES EXCHANGE COMMISSION INTO ANY KIND OF AN OPEN FORUM FOR ANY RESOLUTION OF THESE MATTERS FOR THE PAST DOZEN YEARS). PLEASE RESPOND IN CARE OF CAPITOL HILL QUALITY INN.
